Unfortunately public transit, I wrote a letter to the editor to the Alibi back in 1998 about the lack of public transit and the fact that it was fueling our DWI issues back then. And the fact that there were hardly any other safe ways to get around other than by car or taxi at the time. The buses were barely functional. So, the buses have gotten a lot better. But ultimately I think that Albuquerque needs to focus a lot more funding and energy on public transit including improving ART, possibly street cars, light rail. But definitely biking infrastructure, and multi-modal transportation of all kinds. I would love to see way more protected bike lanes than there are here now, some of the bike lanes I have seen on maps I don't consider bike lanes like the ones up and down Coal and Lead, which is near where I live, those are not bike lanes. I would never get on there. And I used to ride in New York on the regular, I used to commute to my job in Manhattan from Brooklyn by bike most days. It's terrifying here and I'm just hoping that my voice along with many, many, others, we'll start to see some changes.
