• In-meeting Comments:

- Peggy Norton. I am here on behalf of the North Valley Coalition to encourage you to not ratify the change in the designation of Menaul, west of I-25, which is within our boundaries. East of I-25 is very different, and many neighborhoods there lack associations. West of 6th Street has many great features of a multi-modal corridor. It would be better to work on enhancing east of 6th Street rather than change the designation to Major Transit. Which, according to the Comprehensive Plan emphasizes auto-oriented development for much of the corridor. Increased transit frequency and addition of service west of 12th Street could be implemented immediately without a designation change. This is the only east-west multi-modal corridor. Wyoming is multi-modal but I drove around the I-40 interchange area and saw no bike lanes, landscape buffers, etc. Montgomery is a major transit but is a 40-minute bus service. Three or four adjacent neighborhoods and the Coalition submitted letters of opposition, and Los Duranes, the 4th, helped write our original letter to EPC. It is an insult to ignore this opposition in a local neighborhood issue and our City Councilor voted against the approval. While the legislation was presented as only an update to the Comprehensive Plan, there are land use entitlements that go with the designation, and IDO amendments are being proposed to allow others. While it was spoken at City Council that there are no differences between multi-modal and major transit, items such as landscape buffers are usually omitted from the plans without intensive pressure from neighborhoods- note Restaurant Depot, Maverick, and the redevelopment plans for American Furniture. This resolution has little to do with transit and more to do with densification and commercialization. Thank you for considering our request.

• **Presentation:** *Public Sidewalks, City Ordinance, and ADA Improvements* – Perry Hampel, Construction Project Manager, CABQ Department of Municipal Development

- The City of Albuquerque has a sidewalk ordinance, a portion of which states that the adjacent abutting property owner is responsible for the maintenance and repair of that sidewalk.
- The City does not have the capacity to proactively evaluate all of the sidewalks across the city and instead responds to 311 calls. If a violation is observed, a notification is issued to the

property owner. The property owner has 90 days to complete the repairs. If the repairs are not completed, the City sends a second, and final notification that if the repairs are not completed, the City will make the repairs and send the property owner an invoice for those repairs. Those repairs are made by one of two on-call contractors.

- Currently, there are around 850 violation locations that are being tracked across the city, which is only a portion of the sidewalk issues that exist in total.
- There are approximately 4,000 linear miles of sidewalk in Albuquerque.
